Abstract: Non-Destructive Testing/Evaluation involves the use of multiple technologies and methodologies. The right application is essential to provide engineers with valuable information to make informed decisions with regards to evaluating modification, retrofit, construction errors, damage, & deterioration in concrete and masonry structures. While technology can be great, using well thought out methods of applying the technologies is the key to providing information of value. This presentation will show practical case study examples of various applications. Most engineers and contractors will surely recall a project where the techniques and results shown could have solved problems. The technologies presented include: Electromagnetic Methods, Sonic/Ultrasonic Methods, Electrical Methods, Visual, and In-situ Strength Testing.

## FEBRUARY MEETING RECAP

The North Texas Chapter had the pleasure of welcoming the Chair of ICRI's Technical Activities Committee, Mr. Fred Goodwin, to their February meeting held at the Las Colinas Corporate Center in Irving, Texas. A Fellow of ICRI, ACI and ASTM, and a NACE Certified Corrosion Technologist, Fred is one of the true "rock stars" in ICRI, working tirelessly behind the scenes, handling the reins of TAC, ensuring that ICRI's technical offerings are properly vetted according to consensus criteria. A chemist with over 30 years in the construction chemicals industry, he currently leads BASF's Construction Chemicals Global Corrosion Control Competency Center.

Sprinkled with a bit of chemical humor, Mr. Goodwin provided a large group of NTX members and guests with a very informative presentation on the mechanisms of corrosion in concrete, making sure to define the terms that may not have been familiar to the non-chemists in the room. He reviewed the history of concrete, noting that 12 billion cubic meters of concrete gets placed globally each year, and that corrosion in concrete costs \$1.25 billion per year to mitigate. Fred reviewed various ways to prevent corrosion, including numerous methods to provide protection for concrete containing embedded steel reinforcing, such as coatings, membranes, penetrating sealers, surface applied corrosion inhibitors, the use of galvanic anodes, and impressed current cathode protection. He also explained his basic "DDAS" design philosophy – "Don't Do Anything Stupid", and that concrete maintenance is best performed sooner rather than later. Sage advice from a true concrete guru!

### Overview & Program Guidelines

**Objective:** To encourage participation in the concrete and/or concrete repair industries. Scholarship funding is provided by ICRI NTX.

**Amount:** At least \$1,000 for tuition, fees, and books (more than one scholarship may be awarded)

**Eligibility:**<sup>1</sup> High school seniors and college undergraduate students that are pursuing a certificate or degree from a college, university, or trade school.

**Apply:** Submit the following:

Transcripts<sup>2</sup>  
Test scores<sup>3</sup>

**Due Date:** Friday, April 12, 2019

**Review:** Completed applications will be reviewed by the Chapter Scholarship Committee. Appointed by the Chapter President, the Chapter Scholarship Committee Chair selects two committee members, who are approved by the Board of Directors. Applicant interviews may be requested by the Scholarship Committee. Committee members' family members are excluded from the opportunity to apply, but all others are eligible to apply regardless of membership in ICRI.

**Decision:** Award recipient(s) will be notified via letter on or about May 17, 2019. An announcement of the award recipient(s) will be made during an ICRI NTX Chapter meeting.

**Award:** Funding will be awarded by July 1, 2019 and will be placed in an account under the award recipient's name at his or her college, university or trade school. If no school has been selected or if student ID number and school financial aid mailing information has not been provided as of this date, funding will be held until a school is selected. Award will only be sent directly to college, university or trade school, not to award recipient.

**Follow-up:** Award recipients will be expected to attend a NTX Chapter meeting (at no cost to the recipient) and to provide a follow-up letter (or e-mail) at the completion of the semester for which funding is allocated including a description of the coursework completed and grades earned.

<sup>1</sup> While preference will be given to full-time students pursuing a career in concrete restoration, concrete strengthening methods, concrete repair material research or related fields, students from all disciplines are invited to apply. Past recipients may reapply.

<sup>2</sup> Applies to high school senior and college undergraduate applicants, unofficial transcripts are acceptable

<sup>3</sup> Applies to high school senior applicants only, ACT or SAT scores are acceptable






